## Emergency Service Personnel Duty Form

I, the undersigned, understand that duties that I may engage in as an Emergency Service Provider of the Evansdale Fire Department includes the following;

- 1) Involvement in emergency incident operations, which may include fire, emergency medical, natural disaster, hazardous material, storm watch, search and rescue related, or any special circumstances which may arise which presents a hazard to the safety and well being of citizens in the Evansdale Fire Rescue or Communities that have requested the Evansdale Fire Department for Assistance.
- 2) Participation in training and educational activities related to my duties as Evansdale Emergency Service Personnel. Said training may require a service clause which will require me to provide a specified number of months/years service to the Evansdale Fire Department or be required to reimburse the City of Evansdale for all or part of the costs associated with my training.
- 3) Participation in competitive events involving Emergency Service Personnel from other jurisdictions.
- 4) Assistance at fund raising and public education/public relation events hosted or participated in by the Evansdale Fire Department.
- 5) Maintenance and upkeep of Facilities and Equipment owned by the Evansdale Fire Rescue and the Evansdale Firefighters.
- 6) Attendance at meetings, conferences, and conventions relating to my duties as Evansdale Emergency Service Personnel.
- 7) Travel to and from all events listed from 1 thru 6 in either Evansdale Fire Department or privately owned transportation vehicle.
- 8) Compliance with membership requirements as specified in the Rules and Regulations of the Evansdale Fire Department.
